Dear Dr. Hite:

As a follow-up to my Office's June 2015 report on the conditions of Philadelphia's Public School buildings, we recently inspected 15 of the initial 20 schools to determine if any action was taken to improve the hazardous conditions uncovered by our inspectors. These selected schools were determined to need the most work.

After conducting our inspections, we found the School District took immediate steps to make several improvements based on our recommendations. Our inspectors found a substantial amount of the maintenance work had been completed over the summer break prior to students and staff returning for the new school year.

The enclosed report contains a status update to prior findings as well as before-and-after photographs to display the work that was completed. The asbestos that was exposed at Francis Scott Key Elementary has been encapsulated, properly sealed and the plaster ceiling above it has been repaired. The heating system that was leaking in Frankford High School's basement now has new pumps and isolation valves so water does not escape. Additionally, many schools have new ceiling tiles, fresh paint and GFCI electrical outlets have been installed to meet industry standards.

As a result of our report, we were informed that the School District also developed a detailed remediation plan of action to address the types of issues that were found in our initial report. Along with taking corrective actions, the School District indicated that it has established plans to utilize capital funds to address some of the larger and more expensive issues.

I commend your effort and commitment to quickly addressing these unsafe conditions. While there is still much work to be done, this was an enormous leap forward to creating a safe learning environment for students, teachers and other essential staff that assist the School District in its daily operations.

PHILADELPHIA SCHOOL DISTRICT Follow-up Review of Conditions at School Buildings

September 2015

In our June 2015 report the Controller's Office recommended that the Philadelphia School District develop a detailed corrective action plan to address the findings that were presented in the review.

We also recommended management take the following actions to address the deficiencies found in our review. These issues are low cost items that could be completed by the school maintenance staff.

- Cover exposed wires
- Install GFCI outlets where appropriate
- Locate leaks and address as necessary
- Unblock fire exits
- Repair fire signs as necessary
- Update fire extinguishers as necessary
- Establish and maintain a regularly scheduled fire extinguisher maintenance program
- Repair safety surfaces and other tripping hazards
- Inspect all toilets and immediately address those that are unsanitary
- Unclog area drains
- Repair insulation in occupied areas at a minimum
- Check mechanical rooms for leaking; develop a plan to identify and correct the existing problems

As a result of our report we were informed that the School District had developed a detailed remediation plan of action to address the types of issues that were found in our audit. A substantial amount of the maintenance issues at the schools that were inspected by our office have been corrected and plans are in place to utilize capital funds to address some of the larger and more expensive issues. The School District intends to initially make improvements to those schools we inspected and eventually/subsequentially expand their improvements district wide.

The Controller's Office visited 15 of the 20 schools indicated in our audit as a follow up to our report and the School District's plans. (Those 15 schools were revealed in our prior inspections as needing the most work.) During our visits we met with the building engineer and verified that the work had been preformed, and were also provided with a list of completed work for each school. Our inspectors found that a substantial amount of the maintenance work had been completed at these schools. Although the majority of the more expensive work had not yet been completed, we were told that that work would take more time because most of these improvements would require capital funding. The School District appeared to have taken our audit seriously and worked hard to repair many of the items from the report.






