

Philadelphia Charitable Water Discount Totals Nearly \$5M



As 2024 begins, the **Philadelphia Sweetened Beverage Tax** starts its eighth year of existence. To date, the Philadelphia Beverage Tax (PBT) has raised over **\$518M** in revenue for the city. The City has collected more than **\$73M** in revenue each year from the PBT, except in FY20 and FY21 when the city collected about **\$70M** each year. The yearly average is **\$73.8M**.

The largest program supported by the Philadelphia Beverage Tax is **PHLPreK.** In the first six months of the program, there were 2,000 slots at a cost of **\$5,100** per slot. The first full year of the program started on *July 1, 2017*. That year there were again 2,000 slots but the cost increased to **\$8,500** per slot. By this fiscal year FY24, it has grown to **\$10,000** a slot with 5,250 slots. The yearly cost covers ten months of schooling.

Additionally, **Rebuild** has completed 17 total projects. In 2018, Philadelphia issued a **\$79M bond** for **Rebuild** and is expected to pay back an additional **\$47M** over 20 years in debt service for a total of **\$126.4M** in total costs.
